## Five Churches Sign on with Building God's Way

Local Churches needing new facilities are finding the Building God's Way program is a blessing. Five area churches have signed on to build their new facilities using Building God's Way. A construction program that incorporates Biblical principals is a good fit for churches with growing memberships who are concerned with practicing good stewardship.

Building God's Way's emphasis on Biblical stewardship is an attraction for ministries with limited budgets who also see the importance of investing in quality facilities. **Willott Community Church**

in St. Peters is the first area ministry to have their BGW design under construction. Willott's multipurpose and classroom addition should be completed late this Spring.

**Union Avenue Christian Church** in Moberly has completed their custom design as well and is nearing the end of the working drawings phase. They plan to break ground as soon as possible. Two other churches have also finished their custom designs and are looking into capital campaigns and financing possibilities. **Lafayette Church of Christ** in Ballwin and **Apostles Lutheran** in Dardenne Prairie

finished on-site charettes where Daniel Cook and Associate architects designed their new facilities to fit the needs of their respective ministries.

The most recent church to join the BGW team is **Immanuel Lutheran** in Wentzville. The building committee unanimously

recommended Building God's Way and the congregation voted affirming their decision. A design charette will be scheduled in the near future to begin the process of turning another vision into a reality.

In school we read that Thomas Edison made light, but in Sunday School they said you did it first. Did he steal your idea?

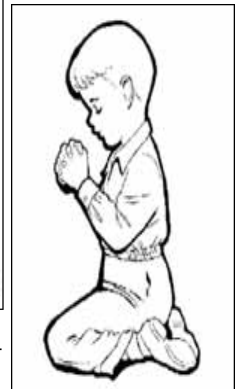

# Hide and Seek: Finding Finances

## Legal Commentary: Church Involvement in Politics



Edmund Burke has apply commented, "The only thing necessary for evil to succeed is for good men to do nothing." In this election year many churches face the controversial question of what role they should play in equipping their members to battle evil and support good in the political arena. The following is a thoughtful commentary from the Pacific Justice Institute on Church Involvement in Politics:

Most Americans have heard the phrase "separation of church and state," but it particularly rings loudly during election time. And with President Bush's recent endorsement of the Marriage Amendment, the call to churches to be politically involved will seem even more resonate. The fact is, churches generally want to encourage their members to vote and be good citizens, but they also want their members to vote intelligently, fully informed on the issues. But how far is too far?

The fact is, churches have complete freedom to register their voters, to express concern over issues, to occasionally comment on legislation and initiatives, and

even mention candidates behind the pulpit, so long as the pastor makes it clear the church is not endorsing any single candidate. Churches can even set up tables where members may place political information for anyone who is interested. For example, we were recently contacted about a letter written by Dr. James Dobson endorsing Jim Gibson, a candidate for the California Assembly. The churches contacting us wanted to make the letter available, but did not want to be accused of endorsing a candidate. During their consultation, we instructed them to set up candidate forum tables, where members can place letters of endorsement on behalf of different candidates, along with other campaign material.

The bottom line is simple: churches and their members can play a major role in shaping the future of America. Once they know what they can do, it's only a matter of following their divine calling in the roles they are to play.
